LOCATION

The property is ideally located with frontage to Penistone Road (A61) which provides high visibility and receives high volumes of passing traffic daily. Penistone Road is the main arterial route which links suburbs such as Hillsborough and Oughtibridge to Sheffield City Centre. The city centre is approximately 2 miles to the south east, with the nearest Junction of the M1 being 34, approximately 5 miles to the north east.

Nearby occupiers include Morrisons, Swann Morton and Stoneacre.

DESCRIPTION

The property comprises a prominent showroom situated within an established commercial area. The premises provide an open-plan showroom with display frontage.

Internally, the accommodation is arranged over a two levels and benefits from a suspended ceiling with integrated lighting and a large, glazed frontage allowing for natural light. To the rear, there is a roller shutter providing access to ancillary storage. The first floor is currently utilised as further showroom space, offices and storage.

Externally the property benefits from 3 parking spaces

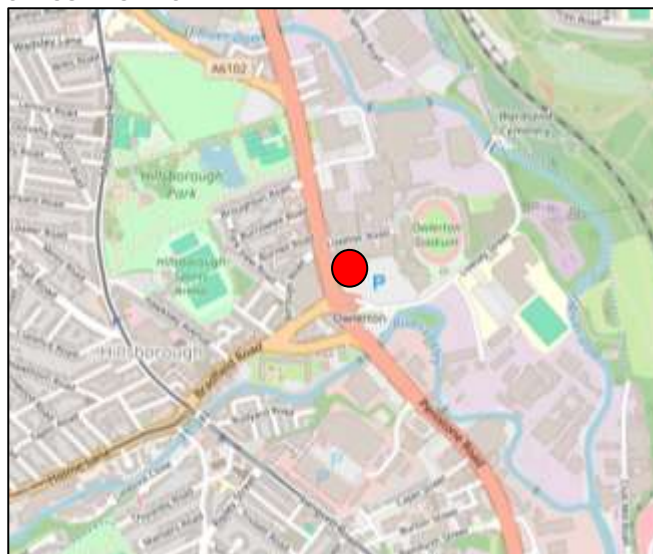
