LOCATION

The property is situated in a prime location at the south end of Ecclesall Road, close to its junction with Psalter Lane.

Ecclesall Road is a retail / leisure hotspot with a number of new offerings opening recently in the immediate vicinity such as Wildcard Bar & Grill, The Dark Horse, The Itchy Pig and Marmadukes Café Deli.

DESCRIPTION

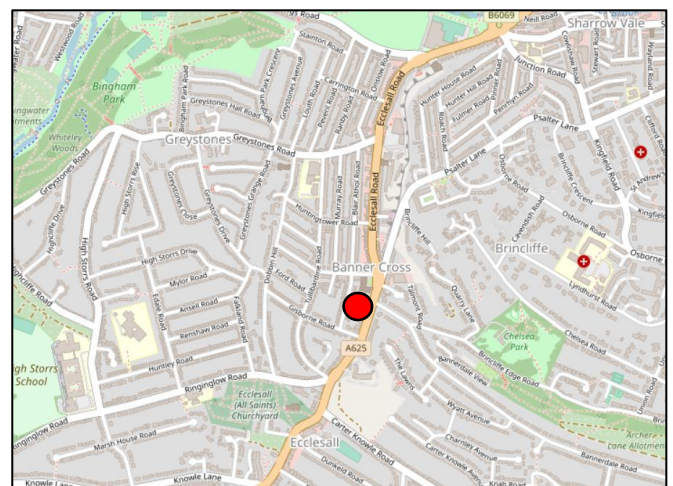
